ORGANIZATIONAL CHART

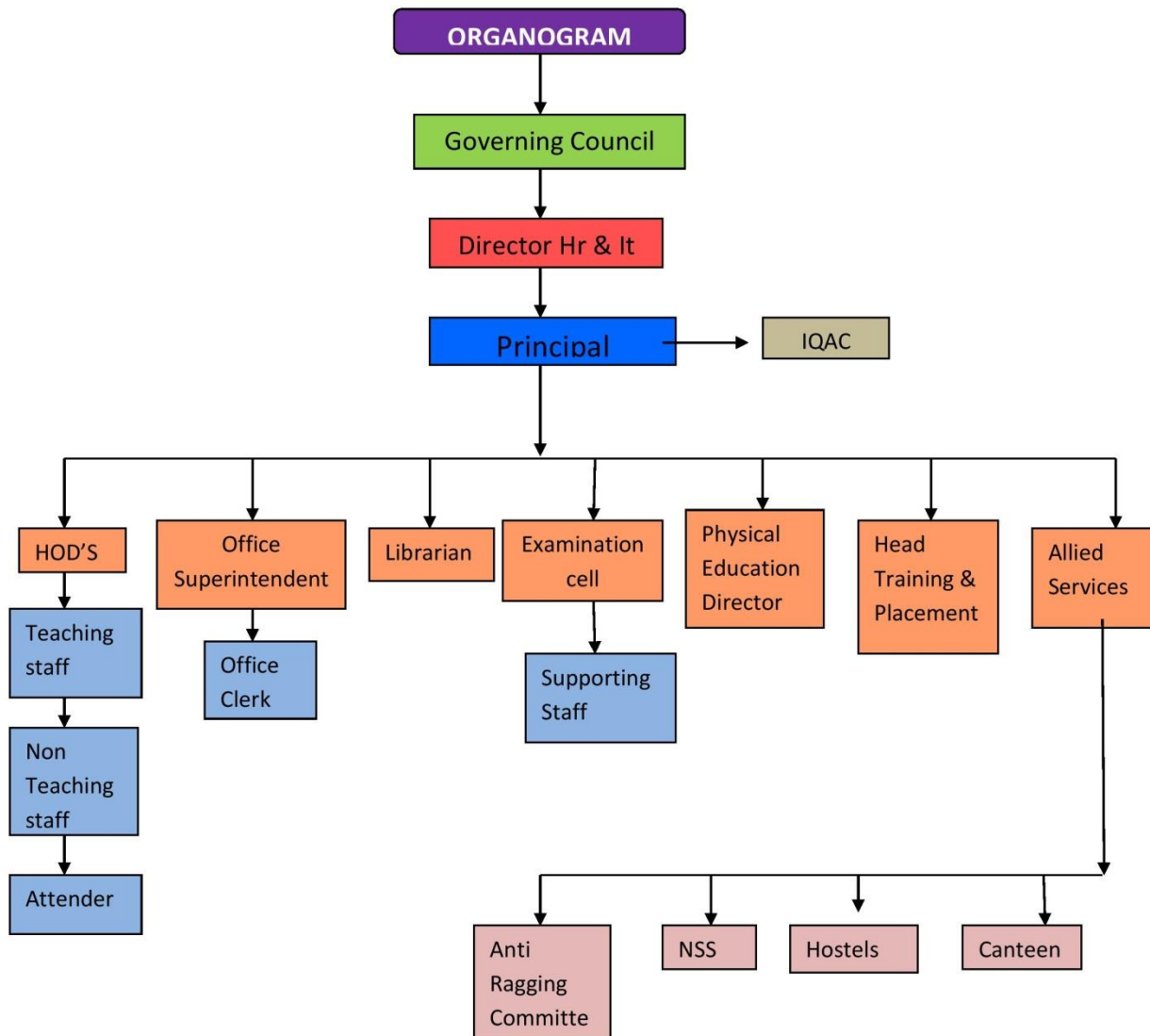




